COVID-19 - till 31st December 2020- के बारे में /reg.

Reference is invited to Department's OMs of even number dated 02/04/2020, 01/05/2020, 08/06/2020 and 29/07/2020 vide which CHSS beneficiaries of DOS/ISRO taking medicines for chronic diseases were allowed to purchase medicines based on the prescription already held by them (prescribed by AMOs/Dept. Medical Officers/panel Specialist etc.), till September 30, 2020 as a special case to reduce the hardships during lockdown, if any, to the beneficiaries.

2. The matter has been reviewed in the Department and it is decided that CHSS beneficiaries of DOS/ISRO taking medicines for chronic diseases shall be permitted to purchase medicines based on the prescription already held by them (prescribed by AMOs/Dept. Medical Officers/panel Specialist etc.), till **December 31, 2020** on the same conditions as per the earlier OM dated 02/04/2020.
